Emergency Response Procedures Plan for Chisago County, Minnesota

This plan provides a framework for responding to emergencies within Chisago County, Minnesota, including key contacts, local authorities, evacuation procedures, first aid and medical assistance, and how to report an incident.

3. Evacuation Procedures

Evacuation Routes and Shelters:

- Designated Evacuation Routes: Primary roads include Interstate 35, U.S. Highway 8, and State Highways 95 and 30. Local adjustments will be made as necessary.
- Evacuation Shelters:
 - North Branch High School - 38175 Grand Ave, North Branch, MN 55056
 - Chisago Lakes High School - 29400 Olinda Trail, Lindstrom, MN 55045
 - Rush City High School - 51001 Fairfield Ave, Rush City, MN 55069
 - Chisago County Government Center - 313 N Main St, Center City, MN 55012

Evacuation Procedure:

- Stay Informed: Follow local news, weather reports, and official social media accounts from authorities (Chisago County Emergency Management, local police/fire).
- Follow Authorities' Instructions: Evacuations will be directed by local law enforcement or emergency management personnel.
- Secure Your Site: Secure windows and doors, unplug appliances.
- Leave Early: Leave promptly if an evacuation order is given.
- Special Needs Assistance: Contact Chisago County Emergency Management at (651) 257-4100 for assistance.
- Stay Together: Evacuate with the team when possible.

4. First Aid and Medical Assistance and Mental Health Crisis Support

First Aid Procedures:

- Basic First Aid Kit: Include bandages, antiseptics, gloves, scissors, burn cream, and pain relievers.

General Reporting Procedures:

- Immediate Emergency Situations: Dial 911.
- Provide clear details about the emergency.

- Notify your Project Manager or Supervisor first.
- If safety-related, notify Amy Robertson (HR) or Compliance Coordinator.
